General Terms of Publication

1. Rights of authors

The following rights are retained by authors:

- Patent and trademark rights to any process or procedure described in the article.
- The right to include the article in full or in part in a thesis or dissertation provided that this is not to be published commercially.
- The right to photocopy or make electronic copies of the article for their own personal use, including for their own classroom use, or for the personal use of colleagues, provided that the copies are not offered for sale and not distributed in a systematic way outside of their employing institution (e.g. via an e-mail list).
- The right to retain a pre-print version of the article on an electronic public server.
- The right to post the final published version of the article on a secure network (not accessible to the public) within the author's institution. Posting the final published version of an article on a public file server as on the World Wide Web can only be done with WRFPM 2017's prior written permission.
- The right, subsequent to publication, to use the article or any part thereof, free of charge in a printed compilation of works of their own, such as collected writings or lecture notes.
- If the article is a 'work for hire' made within the scope of the author's employment, the employer may use all or part of the information in this article for intra-company use.

4. US Government employees

- If there is a number of co-authors, of which at least one is a US Government employee (and this work was prepared in such capacity) and at least one is not a government employee, the non-government author should sign this form, indicating transfer of those rights which such author has (also on behalf of any other non-government co-authors).

5. Crown Copyright
